Mission Statement

Identi-Check, Inc. (IDENTI-CHECK) is a Springfield-based corporation offering a full preemployment background screening service statewide. Using state-of-the-market technology, we accomplish our mission of helping employers "**Know Who You Hire.**" Identi-Check will provide a 72-hour turnaround on all background checks submitted by 2:00 p.m. Requests received after 2:00 p.m. are processed on the next business day.

IDENTI-CHECK provides pre-employment screening for both the private and public sectors. Our primary goal is to assist employers in hiring the right people in a timely manner. IDENTI-CHECK performs over 16 types of searches, including statewide criminal history inquiries in less than 72 hours.

The primary purpose of pre-employment screening is to protect not only an employer's assets as well as the employee's safety, but also their well-earned reputation. Background checks are being recommended as the most efficient way to identify candidates with violent criminal histories to reduce the risk of violence on shop floors and in offices. The IDENTI-CHECK Screening Procedures

Identi-check's Customer Service Representatives (CSR) receives requests from clients for preemployment background screenings of potential candidates via the internet, fax, phone or mail. The CSR will process existing clients' requests immediately and assist new clients in setting up a subscriber account. The type of account, pricing and method of payment will be influenced by factors including whether the requester is a member of a client association and by the volume of business represented. New customers must establish an account and provide Identi-Check with the documentation and authorizations required to perform confidential background screenings.

Each request will be processed immediately by Identi-Check through contact with the appropriate information source using the prescribed procedure. Responses will be electronically merged into a report format, reviewed by a supervisor, and forwarded directly to the client. Submitted Statewide Criminal searches to the Illinois Sates Police decrypting database are occasionally backlogged and can take a few days longer than normally.

Fingerprinting —Subjects need to be fingerprinted based on information received from the Illinois State Police. Subjects must be fingerprinted at a local police department and results are available in 2-3 months. Identi-Check will provide the fingerprinting cards. Staff will present the card to the subject with instructions to proceed to a local police department for fingerprinting. The subject will return the completed card to the potential employer and, in turn, they will return the card to Identi-Check along with a processing fee. In most cases, the fee is \$15.00 per subject. This procedure will be necessary when subjects name is very common and results are unclear. This is also a necessity when a subject name and information was previously used in an unlawful or falsified manner by a subject trying to hide there background by using someone else name and information. Identity theft is at an all-time high and is not be taken lightly.
